RICHARD J. BROWN is a community activist.

Some years ago he looked at a community dynamic that placed Black community members and the justice system at extremes, 36" and 0 on a yardstick. Feeling that the answers were to be found at 18" he firmly took a position there and found others looking for some neutral ground to begin having discussions that could lead to solutions. He remains steadfast at 18". An early advocate of Community Policing, Richard J Brown for over fourteen years facilitated Hope and Hard Work, a weekly community meeting bringing together community members with Portland Police, city and county resources. Tirelessly he assisted in reaching solutions to neighborhood concerns, from problems with neighbors to criminal activities. He led a very aggressive foot patrol for eighteen months, five hours a night, seven days a week, reducing crime in the area. A committed advocate for Community Policing he was one of the original members of the Chief's Forum serving as the mayors representative. His community involvement includes Albina Head Start and Albina Early Head Start. Citizens Crime Commission, and volunteers at the Blazers Boys and Girls Club. He also facilitates a weekly, County re-entry program, the African American Program for men and women on parole or probation. He has served on the advisory boards for the N/E Community Court and the Oregon Police Corps. As an instructor with the Western Community Policing Center he has taken the philosophy of Community Policing through out the region and beyond. Serving two terms as the Community Representative to the Department of Public Safety, Standards and Training, where he actually sat in on trainings a couple days a week. At the end of his term, the Director of DPSST finding value to his assessments of and suggestions to the training, asked that he continue his presence at DPSST.
